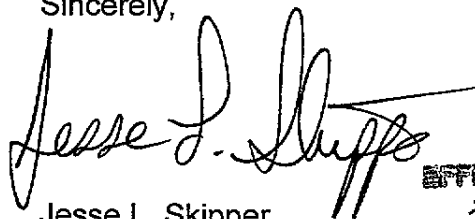

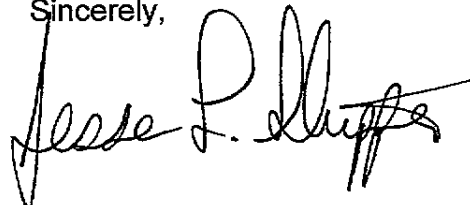

ARTICLES OF INCORPORATION  
OF  
CREATIVE WINDOW FABRICATIONS, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I  
Name

The name of the Corporation ("Corporation") is Creative Window Fabrications, Inc.

ARTICLE II  
Effective Date; Existence of corporation

The existence of the Corporation shall begin on the earliest of March 5, 2002 or the date of filing these articles of incorporation and shall exist perpetually.

ARTICLE III  
Principal Place of Business

The street address of the principal office of the Corporation is 6320 39<sup>th</sup> Street North, Pinellas Park, FL 33781.

ARTICLE IV  
Authorized shares; shares uncertificated

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. The shares of the Corporation shall not be represented by share certificates. Issuance of shares shall be memorialized in the resolutions of the board of directors and by entry of the name and address of all persons to whom shares are issued in the stock register.

ARTICLE V  
Shares not transferable

The shares of the corporation shall not be transferable to a third party except upon the affirmative vote of 100% of the shares then authorized to vote.

Preemptive rights

Shareholders shall have preemptive rights in any shares issued by the corporation.

ARTICLE VII  
Registered office

The initial street address of the Corporation's registered office is 6320 39<sup>th</sup> Street North, Pinellas Park, FL 33781. The initial registered agent for the Corporation at that address is William L. Goodman.

ARTICLE VIII  
Board of Directors

The initial board of directors shall consist of one member. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. The name and address of the person who will serve on the initial board of directors is William L. Goodman, 3360 Shore Acres Boulevard NE, St. Petersburg, FL 33703.

ARTICLE IX  
Incorporator

ARTICLE X  
Indemnification

The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

Amendment

These articles may not be amended except the affirmative vote of 100% of the shares then authorized to vote.

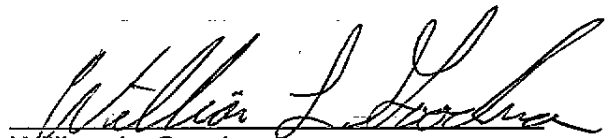
