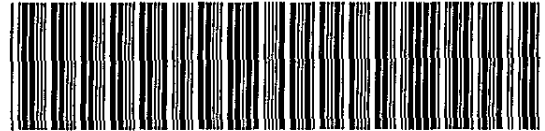

**THIRD:**




