ARTICLE I

THE UNDERSIGNED, acting as sole incorporator of K.C. Collignon, CFP, Consulting Services, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be K.C. Collignon, CFP, Consulting Services, Inc.

Initial Board of Directors


