ARTICLE I - NAME

The name of this corporation is ARCHITECTURE ALUMINUM, INC., with its principal office and address being located at 1436 N.E. 56th Street, Apt. 3, Fort Lauderdale, 33334.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.


