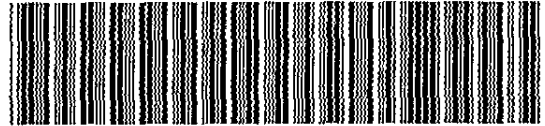

AUTO PRO SOUTHEAST, INC.

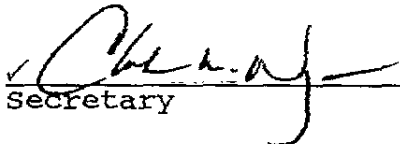
Changing its Name to
