ARTICLES OF INCORPORATION
OF

INTELLEXIA GLOBAL SERVICES CORP.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Intellexia Global Services Corp.

ARTICLE II

The existence of the Corporation shall begin on March 6, 2002.

ARTICLE III

The street address of the principal office of the Corporation is 1001 Brickell Bay Drive, Suite 2112, Miami, Florida 33131.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is One Million (1,000,000), par value \$1.00 per share, all of which shall be Common Shares.
