**ARTICLES OF INCORPORATION
OF
JACKSONVILLE MERIDIAN USERS GROUP, INC.**

Pursuant to the provisions of Chapter 617, Florida Statutes, The Florida Not For Profit Corporation Act, JACKSONVILLE MERIDIAN USERS GROUP, INC. hereby states the following Articles of Incorporation:

ARTICLE I

Name

The name of this corporation shall be: Jacksonville Meridian Users Group, Inc.

ARTICLE II

Principal Office

The principal place of business and mailing address of the corporation is 4063 Ponce de Leon Avenue, Jacksonville, Florida 32217.

ARTICLE III

Purposes

The specific purposes for which the Corporation is organized is to educate and inform members in all areas of telecommunication.
