ARTICLE I - NAME

The name of the Corporation is Aaron S. Dubrinsky D.O. P.A.

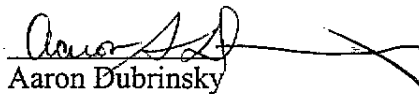
ARTICLE VI – BOARD OF DIRECTORS

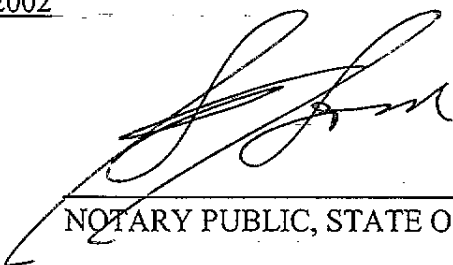
