1. Ricardo R. Lowe is the President of MIASIMONE, INC., a Florida corporation, (hereinafter "Corporation").
2. That the Corporation was administratively dissolved by the Florida Department of State on September 19, 2003.
3. That the Corporation failed to file its 2003 and 2004 Annual Report or pay the 2003 and 2004 Annual Report filing fee within the time prescribed by Florida Statutes Chapter 607 because:

6. No further ground or grounds exist for the administrative dissolution of the Corporation.

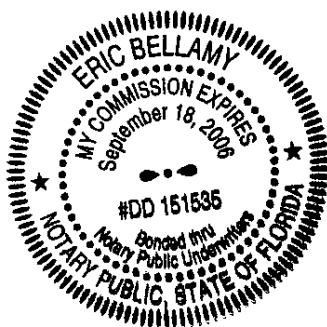
