ARTICLES OF INCORPORATION
OF

The undersigned, acting as the incorporator of Fowke Commercial Contractors, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.




ACCEPTANCE OF REGISTERED AGENT
