

The name of the corporation is PG&E ENTERPRISES, INC. The principal address of the corporation is: 1214 NW 23 TERR., FT. LAUDERDALE, FL. 33311.

The period of its duration is perpetual.

The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) of no par value.


ARTICLE FIVE
