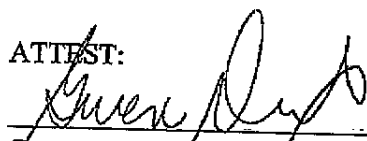
"1. Name

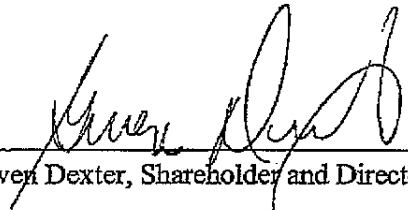
