ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Law Offices of John C. Norman, P.A. and its principal place of business shall be located at 7555 S.W. Highway 200, Suite 300, Ocala, Florida 34476.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

ARTICLE IV - CAPITAL STOCK

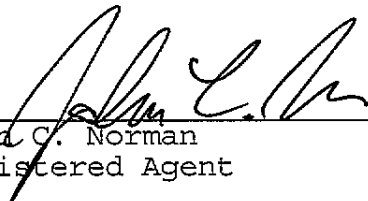
