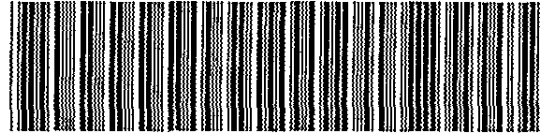

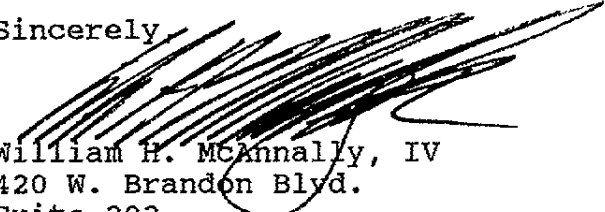

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment(s) adopted:

a. Article I of the Articles of Incorporation shall be amended to read as follows:

ARTICLE I - NAME

The name of this corporation shall be: COUNTRYWIDE TITLE COMPANY.

b. Article III of the Articles of Incorporation shall be amended to read as follows:

ARTICLE III - PURPOSE

The purpose of this corporation is to provide title insurance; and escrow and closing services regarding real estate transactions.

c. Article VII of the Articles of Incorporation shall be amended to read as follows:

ARTICLE VII

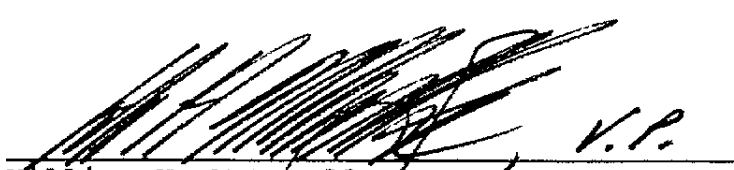
