The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "Corporation") is Williams Cabinet Installation, Inc.

SECOND: The address wherever located, of the principal office of the Corporation, if known is 21818 Pineywood Loop, Land O Lakes, FL 34639.






SEVENTH: The purpose for which the Corporation is organized, which shall include the authority of the Corporation to engage in any lawful business for which corporations may be organized under the Florida Business Corporation Act, are a follows:
