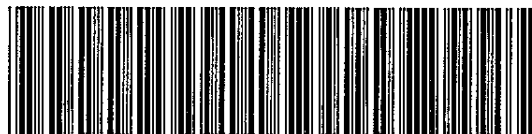

FIRST: Article I of the Articles of Incorporation, as amended, is hereby amended to read:

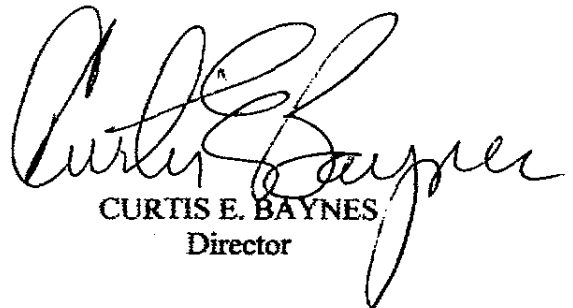
ARTICLE I

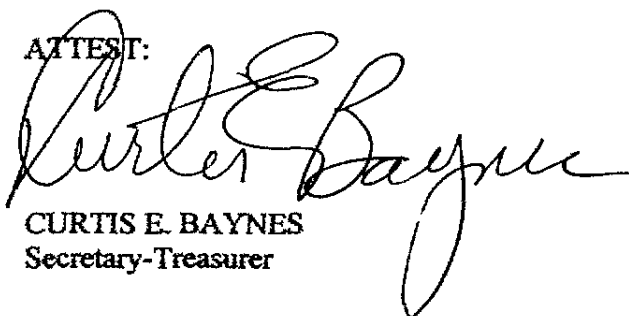
SECOND: The date of the adoption of the amendment is May 14, 2003.
