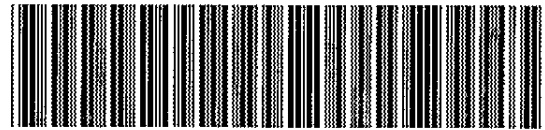

**AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF**

Pursuant to the provisions of section 607.1006, Florida Statutes, Tallahassee Property Services Inc. adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article IV of the Articles of Incorporation, as amended, is hereby amended, as follows:

ARTICLE IV

The corporation shall have the authority to issue ten thousand (10,000) shares of common stock with a par value of ten dollar (\$10) per share.

SECOND: The Articles of Incorporation, as amended, are hereby restated in its entirety to read:

ARTICLE I

The name of the corporation is "Tallahassee Property Services Inc." The principal place of business is: 8105 Old Saint Augustine Road, Tallahassee, Florida 32311-8538. The mailing address of the corporation is Post Office Box 1203, Tallahassee, Florida 32302-1203.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The corporation may engage in any lawful business permitted pursuant to United States and Florida Law.

ARTICLE IV

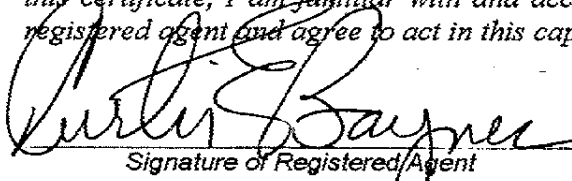
The corporation shall have the authority to issue ten thousand (10,000) shares of common stock with a par value of ten dollars (\$10) per share.

Secretary-Treasurer : Curtis E. Baynes

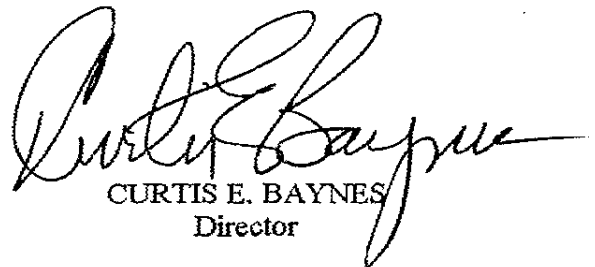
ARTICLE IX

These Articles of Incorporation shall become effective upon filing with and approval by the Secretary of State as indicated by an endorsement hereon with the date and time of approval set forth on a duplicate and may be amended in any manner consistent with Florida Law; provided, however, every amendment shall be approved by the stockholders by at least a majority vote of the stock entitled to vote thereon.

THIRD: The date of the adoption of the amendment is November 25, 2003.

FOURTH: The board of directors adopted the Amendment without shareholder action and shareholder action was not required.
