**ARTICLE I.**  
**CORPORATE NAME**

**ARTICLE II.**  
**ADDRESS OF CORPORATION**

**DURATION**

The corporation shall have perpetual existence, commencing on the date of the execution and acknowledgment of these Articles or upon filing.


