ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

BARGAIN BOB'S CARPETS OF MARTIN, ST. LUCIE & INDIAN RIVER COUNTIES, INC.



Pursuant to the provisions of 607.1003 and 607.1006 of the Florida Business Corporation Act (the "Act"), Bargain Bob's Carpets of Martin, St. Lucie & Indian River Counties, Inc. (the "Corporation") adopts this Amendment to the Articles of Incorporation set forth below:
