ARTICLES OF INCORPORATION OF WAKULLA SILVER SPRINGS COMPANY

Pursuant to the requirements set forth within Chapter 607 of the Florida

Business Corporation Act, the undersigned, being a natural person, does hereby act as the incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.
