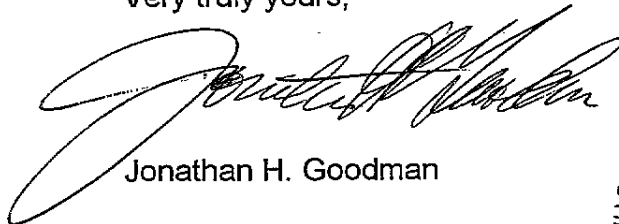

ARTICLES OF INCORPORATION

OF FORSLUND OFFICE SYSTEMS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

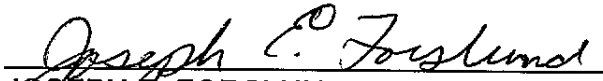
ARTICLE VII.

The name and address of the sole incorporator is Joseph E. Forslund, 1063 Hammond Boulevard, Jacksonville, Florida 32221.

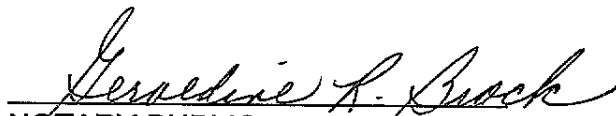

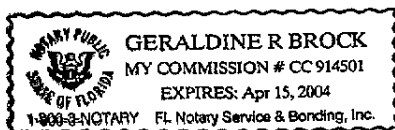
