The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby forms a Corporation for profit under Chapter 607 of the Florida Statutes (2001).

ARTICLE 1 - Name

The name of the Corporation is MARTEEN, INC.

These Articles of Incorporation shall be effective immediately upon execution.


