The undersigned incorporator for purposes of forming a professional service corporation under section 621.05, Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the Corporation is JULIO C. LORA M.D., P.A. (the "Corporation").
- SECOND:** The street address of the initial principal office and mailing address of the Corporation is 777 E 25th St. Suite 112 – Hialeah, Florida 33013.
- THIRD:** The Corporation is authorized to issue 1000 shares of common stock, par value \$1.00 per share.
- FOURTH:** The street address of the initial registered office of the Corporation is: 777 E 25th St. Suite 112 – Hialeah, Florida 33013 and the registered agent at that address is: Julio C. Lora
- FIFTH:** The name and address of the incorporator of the Corporation is: Julio C. Lora, 777 E 25th St. Suite 112 – Hialeah, Florida 33013.
- SIXTH:** The general purposes for which the Corporation is initially organized are:

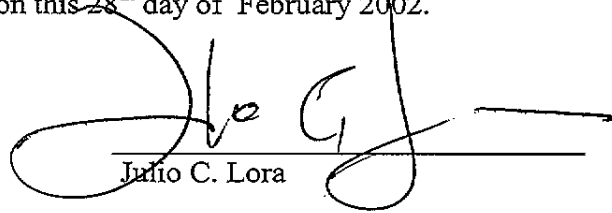
To render the following specific professional service (as defined in Section 621.03 of the Florida Professional Service Corporation Act) and none other, to wit: the personal services rendered by physicians and surgeons as provided by Chapter 458 of the Florida Statutes or any successor statute providing therefor.

And in connection therewith and in furtherance thereof, to possess and exercise all the powers and privileges granted by the Florida Business Corporation Act or by any other law of Florida or by these Articles of Incorporation together with any powers incidental thereto, so far as such powers and privileges are consistent with, and not prohibited by, the Florida Professional Service Corporation Act.

SEVENTH: The Corporation shall have one director initially and the number of directors may be increased or diminished from time to time as provided in the Bylaws but shall never be less than one. The name and address of the initial director of the Corporation is: Julio C. Lora, 777 E 25TH St. Suite 112 – Hialeah, Florida 33013.

EIGHTH: The corporate existence of the Corporation shall commence upon the filing of these Articles of Incorporation.

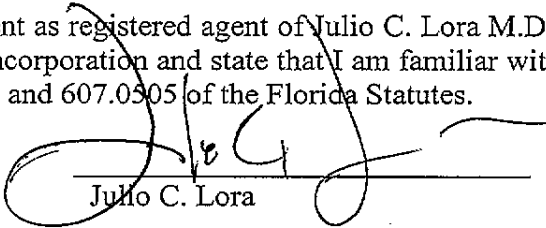
