ARTICLES OF INCORPORATION OF

ARTICLE 1 - Name

The name of the corporation is: Frostaire Refrigeration & Air Conditioning, Inc.

ARTICLE X – Indemnification

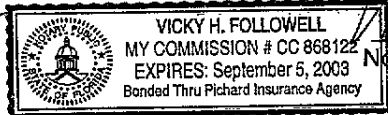
