**ARTICLE I - NAME AND ADDRESS**

The name of the Corporation shall be COREY COMPTON, P.A. The mailing address of this corporation is 4164 Ripken Circle West, Jacksonville, Florida 32224.

**ARTICLE II - PURPOSE**
