Christopher Compton, President of Corey Compton, PA went to file and pay his 2005 Annual Report online at the State's website (sunbiz.com) and discovered that his corporation had been classified inactive. He was going to pay his fee when he received your annual correspondence card as he in the past. However, it seems he never received his initial notice or any subsequent notice requesting payment and additional fees. I suspect that this resulted due to the fact that my client moved four times during 2004, as I know the State is quite reliable in sending such notifications. It is worth noting that Mr. Compton has notified the state of his corporation's current, and now permanent, address.

We respectfully request that you accept our payment of \$300.00, along with the completed "2005 For Profit Corporation Reinstatement" form, as both renewal of Corey Compton, PA's active status and for the 2005 Annual Report. Corey Compton, PA diligently pays its bills by their due date, but does not have a formal system for triggering annual or nonrecurring payments other than the actual receipt of the bill. For this reason, Corey Compton, PA and Mr. Compton had no way of knowing that a payment was due to the State of Florida unless the notice was actually received.

We will review the bank account of Corey Compton, PA to verify that the payment for \$300.00 has cleared the bank account, and upon that event will conclude that this matter has been satisfactorily handled.
