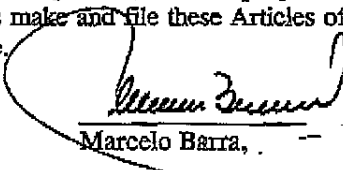
ARTICLE VI.

The first Director shall hold office until the first annual meeting of the Stockholders of the Corporation.

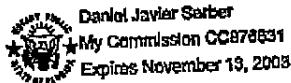

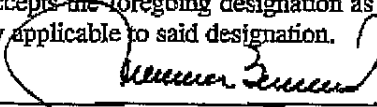
