ARTICLES OF INCORPORATION  
OF  
MOTOR SPORTS CORPORATION OF NORTH AMERICA

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I  
NAME

The name of this corporation shall be:

The Director may authorize and require the payment of the reasonable expenses incurred by the Director in attending meetings of the Directors. Nothing in this Article shall be construed to preclude the Director from serving the corporation in any other capacity and receiving compensation therefor.


ARTICLE XI
