ARTICLES OF INCORPORATION

FILED

I, THE UNDERSIGNED, hereby associate myself for the purpose of becoming a corporation under the laws of the state of Florida providing for the formation, liability, rights, privileges and immunities of 2 MAR -7 PM 3: 48 corporations for profit.

ARTICLE 1: NAME

The name of this corporation shall be as follows:
