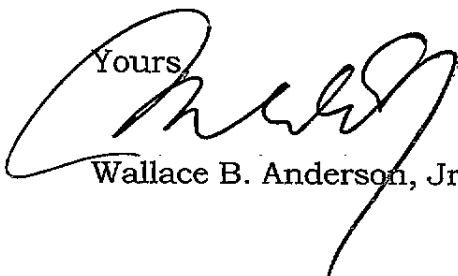

ARTICLE ONE

#### Indemnification

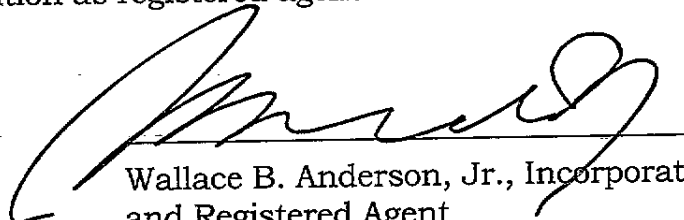
