ARTICLE I - NAME

The name of this corporation is Creative Cycles And Repairs, Inc. and the principal office or mailing address of the corporation is 45 Brown Chapel Road, St. Cloud, FL 34769.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of this filing of the Articles with The Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all-lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exist or may be amended.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue 100 shares of \$1.00 par value common stock, which shall be designated as "Common Shares."

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which the new shares are offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 45 Brown Chapel Road, St. Cloud, FL 34769; the name of the registered agent of this corporation at that address is Tammy J. Gross.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

The corporation shall have two Directors constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time in accordance with the By-Laws; however, there shall never be less than one Director nor more than five. 
