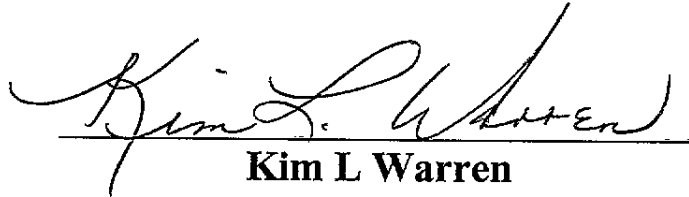
ARTICLE V

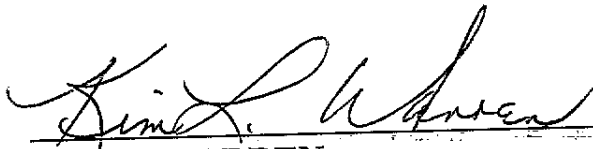

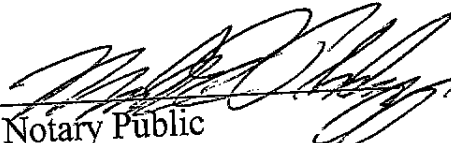
