The Undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME.

The name of this corporation is DECO PAVER BRICKS, INC.

ARTICLE II. PRINCIPAL OFFICE.
