ARTICLES OF INCORPORATION OF ALLSTATES APPRAISAL ASSOCIATES, INC.

The undersigned, a natural person of legal age, does hereby desire to form a corporation under the laws of the State of Florida and does hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be:

ALLSTATES APPRAISAL ASSOCIATES, INC

ARTICLE II. NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

To engage in business of any kind dealing with appraisal of real estate improved and unimproved of every class and description.
