**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
PAT TROXEL & ASSOCIATES, INC.**

The undersigned, for the purpose of amending the Articles of Incorporation of **TROXEL & ASSOCIATES, INC.**, a corporation formed and existing under the laws of the State of Florida, adopts the following Articles of Amendment:

ARTICLE I
Name

The name of this corporation is currently **PAT TROXEL & ASSOCIATES, INC.**, but is being changed by these Articles of Amendment.

ARTICLE II
Amendment to Articles

1. Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

ARTICLE I NAME

The name of the corporation is: **PAT TROXEL, P.A.**

2. A new Article XII is hereby inserted to the Articles of Incorporation to read as follows:

ARTICLE XII PURPOSES

This professional service corporation is organized for the sole and specific purpose of engaging in every phase and aspect of the business of rendering the same professional services to the public that a licensed real property broker, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed or otherwise legally authorized under the laws of the State of Florida to practice as a licensed real property broker. This corporation shall have all the powers conferred upon it by the laws of the State of Florida and not prohibited by the Florida Professional Service Corporation and Limited Liability Company Act; provided, however, that this corporation shall not engage in any business other than the

rendering of the professional services described above for which it is organized. It is expressly provided that the foregoing enumeration of specific purpose shall not be held to limit or restrict in any manner the purposes in which this corporation is otherwise permitted by law to engage.

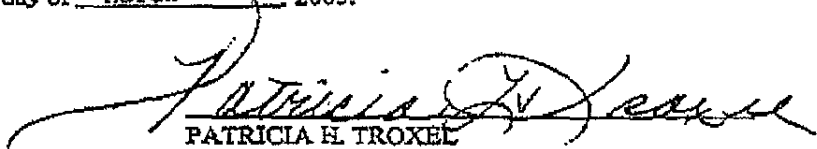
ARTICLE III
