ARTICLES OF INCORPORATION

OF

QUALITY COMPONENTS UNLIMITED, INC.

ARTICLE I

(Name)

The name of this corporation is Quality Components Unlimited, Inc.. The address of the corporation is 3056 Palm Avenue, Fort Myers, Florida 33901.

(Duration)

(Voting Rights)


Except as otherwise provided by law, the entire voting power for the election of Directors and for all other purposes shall be vested exclusively in the holders of the outstanding common shares.

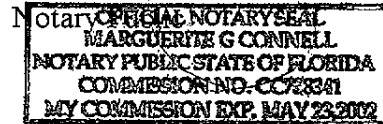


