

ARTICLES OF INCORPORATION OF  
AJ SENIOR SERVICES, INC.

I, the undersigned, for the purpose of forming a corporation for profit pursuant to the laws of the State of Florida, do hereby make, subscribe and file the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be:

AJ SENIOR SERVICES, INC.

ARTICLE II

This corporation shall have the authority to engage in any activity or business permitted under the laws of the United States, and the State of Florida, and any other jurisdiction wherein it may conduct business.

ARTICLE III

This corporation is authorized to issue par value voting stock as described below, and none other:

Maximum number of shares: 1,000,000

Par value per share: \$0.01

The authorized share of par value common stock, may be issued only for a consideration having a value, in the judgment of the board of directors, equivalent at least to the full par value of the stock so to be issued. Such consideration may be in the form of cash, real property, tangible personal property, intangible personal property, labor or services rendered, or any combination of the foregoing or such other considerations allowable by law. Each share of common stock of this corporation shall entitle the holder thereof to one vote upon each proposal presented at lawful meetings of the stockholders. No holder of common stock of this corporation shall be entitled to any right of cumulative voting.

ARTICLE IV

INITIAL CAPITAL

The amount of capital with which this corporation shall begin business shall not be less than one thousand dollars and no cents.




