**ARTICLES OF INCORPORATION
OF

I the undersigned incorporator of a Corporation under the Florida General Corporation Act adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the Corporation is Richard J. Loeb1, LCSW, P.A.

ARTICLE II. NATURE OF BUSINESS

The purpose of this Corporation shall be to engage in psychotherapy consultation with patients of such business and business activity as is permitted and otherwise allowable by law.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at one time is 100 shares, \$1.00 par value stock.

ARTICLE IV. ADDRESS
