ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Faith Gym, Inc

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 3870 W. Broward Blvd. Plantation, Florida 33319

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
