#### ARTICLES OF INCORPORATION OF

#### S.J.R., INC.



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

## Article 1. Name and Address

The name of the Corporation is S.J.R., Inc. The principal office, if known, or the mailing address of the Corporation is 2640 Golden Gate Parkway, Suite 115, Naples, Florida 34105.
