The undersigned Incorporator hereby files these Articles of Incorporation in order to form a Professional Corporation (the "Corporation") under Chapter 607 Florida Statutes and the Professional Service Corporation and Limited Liability Company Act under Chapter 621 Florida Statutes.

**ARTICLE I  
Name and Address**

The name of the Corporation shall be **THE McLEOD LAW FIRM, P.A.** The principal office of the Corporation shall be located at 48 East Main Street, Apopka, Florida 32703, unless and until changed by resolution of the Board of Directors.

**ARTICLE II  
Nature of Business**

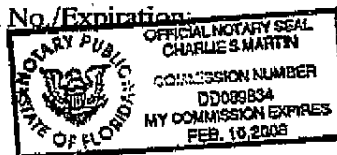
