ARTICLE VIII

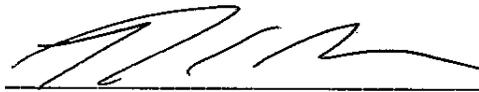
This corporation may select the following officers to govern its day to day affairs:

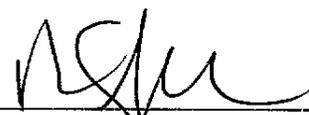
