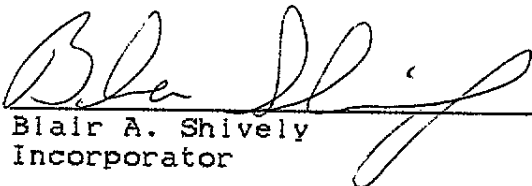

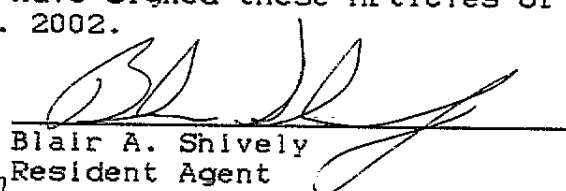
AMENDMENT TO ARTICLES
