The registered agent shall be Syed Hashmi 8107 Lagos De Campo Blvd #124 Tamarac, FL 33321


ARTICLE VI – BOARD OF DIRECTORS



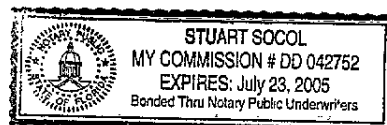
