**ARTICLES OF INCORPORATION
OF
WESTON PERFORMING ARTS, SCHOOL OF FINE ARTS AND CRAFTS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is **WESTON PERFORMING ARTS, SCHOOL OF FINE ARTS AND CRAFTS, INC.**

ARTICLE II

The existence of the Corporation shall begin on MARCH 18, 2002.

ARTICLE III


