ARTICLES OF INCORPORATION OF

WESTON PERFORMING ARTS, SCHOOL OF FINE ARTS AND CRAFTS, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is WESTON PERFORMING ARTS, SCHOOL OF FINE ARTS AND CRAFTS, INC.

ARTICLE II

The existence of the Corporation shall begin on MARCH 1, 2002.

ARTICLE III
