# ARTICLES OF INCORPORATION OF

# GIORDANO'S, INC.

SECRETARY OF STATE The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I

The name of the corporation shall be Giordano's, Inc., hereinafter referred to as the "corporation".

### ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

## ARTICLE III

This corporation shall have all such powers as may be permissible to corporations under the laws of the State of Florida, and all powers necessary or desirable to accomplish the purposes and business of the corporation as hereinabove set forth in Article II.

#### ARTICLE IV

This corporation has the authority to issue one thousand shares of common stock with a par value of One Dollar (\$1.00) per share.

#### ARTICLE V

This corporation is to exist perpetually.

#### ARTICLE VI

The initial street address of the principal office of this corporation in the State of Florida is: 4502 Sunset Drive, Vero Beach, FL 32963. The Board of Directors may from time to time move the principal office to any other address in Florida.

#### ARTICLE VII

This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time, as provided in the By-Laws.

#### ARTICLE VIII

The name and address of the member of the first Board of Directors is: Lena Strumas, 4502 Sunset Drive, Vero Beach, FL 32963.

This director shall hold office until the first annual meeting or until their successors are elected or appointed and qualified as provided in the By-Laws.

## ARTICLE IX\_

The name and address of the incorporator is: Lena Strumas, 4502 Sunset Drive, Vero Beach, FL 32963.

#### <u>ARTICLE X</u>

Unless otherwise provided in the By-Laws, every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which she already holds, shall have the right to purchase her pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others. The By-Laws may provide that every stockholder is not to have the right to so purchase. The By-Laws may provide for cumulative voting for directors and may make provisions governing the issuance of stock certificates to replace lost or destroyed certificates. These directors shall be elected by the shareholder at each annual meeting and the officers shall be elected by the director at each annual meeting. The date of the annual meeting shall be fixed by the By-Laws.

#### ARTICLE XI

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by the majority of the stock entitled to vote thereon, unless all of the directors and all of the stockholders sign a written statement manifesting their intentions that a certain amendment of these Articles of Incorporation may be made.

#### <u>ARTICLE XII</u>

The registered agent for service of process within this state shall be Lena Strumas of 4502 Sunset Drive, Vero Beach, FL 32963.
