**CERTIFICATE OF INCORPORATION
OF
AYARAY ENTERPRISES, INC.**

1. **Name:** The name of the corporation is **AYARAY ENTERPRISES, INC.**
2. **Principal Office and Registered Agent:** Its registered office in the State of Florida is 4401 Akita Drive in the City of Tampa, County of Hillsborough. The name of its registered agent at such address is Falconery Castro.
3. **Purposes:** The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Florida.
4. **Capital Stock:** The total number of shares of capital stock that the Corporation shall have authority to issue One Thousand, all of which are to be common stock with \$1.00 par value.
5. **Directors:** The names of the directors are:
 - Gloria H. Rivera – President
 - Gloria Rivera – Vice President
 - Edwin Arias – Treasurer
 - Falconery Castro – Secretary
 - Roger Espinoza - Treasurer
6. **Incorporator:** The name and mailing address of the incorporator is: Falconery Castro, 4401 Akita Drive, Tampa, FL 33624 The name and mailing addresses of the directors are:
7. **Existence:** The Corporation is to have perpetual existence.
8. **Liability of Stockholders:** The private property of the stockholders shall not be subject to the payment of the corporate debts.
9. **Management:** Subject to the provisions of the laws of the State of Florida, the following provisions are adopted for the management of the business and for the conduct of the affairs of the Corporation, and for defining, limiting and regulating the powers of the Corporation, the directors and the stockholders:
 - (A) The books of the Corporation may be kept outside of the State of Florida at such place or places as may from time to time be designated by the Board of Directors.
 - (B) The business of the Corporation shall be managed by its Board of Directors; and the Board of Directors shall have power to exercise all the powers of the Corporation, including (but without limiting the generality hereof) the power to create mortgages upon the whole or any part of the property of the Corporation, real or personal, without any action of or any the stockholders, except as otherwise provided by statute or by the Bylaws.
 - (C) An increase in the number of directors shall be deemed to create a vacancy or vacancies in the Board of Directors, to be filled in the manner provided in the Bylaws. Any director or any officer elected or appointed by the stockholders or by the Board of Directors may be removed at any time, in such manner as shall be provided in the Bylaws.
 - (D) The Board of Directors shall have power to make and alter Bylaws, subject to such restrictions upon the exercise of such power as may be imposed by the stockholders in any bylaws adopted by them from time to time.
 - (E) The Board of Directors shall have the power, in its discretion, to fix, determine and vary, from time to time, the amount to be retained as surplus and the amount or amounts to be set apart out of any of the funds of the Corporation available for

dividends as working capital or a reserve or reserves for any proper purpose, and to abolish any such reserve in the manner in which it was created.

- (F) The Board of Directors shall have the power, in its discretion, from time to time, to determine whether and to what extent and at what times and places and under what conditions and regulations the books and accounts of the Corporation, or any of them, other than the stock ledger, shall be open to the inspection of stockholders; and no stockholder shall have the right to inspect any account or book or document of the Corporation, except as conferred by law or authorized by resolution of the directors or of the stockholders.
- (G) Upon any sale, exchange or other disposal of the property and/or assets of the Corporation, payment therefore may be either to the Corporation or directly to the stockholders in proportion to their interests, upon the surrender of their respective stock certificates, or otherwise, as the Board of Directors may determine.
- (H) In case the Corporation shall enter into any contract or transact any business with one or more of the directors, or with any firm of which any director is a member, or with any corporation or association of which any director is a stockholder, director or officer, such contract or transaction shall not be invalidated or in any way affected by the fact that such director has or may have an interest therein which is or might be adverse to the interests of the Corporation, even though the vote of such director might have been necessary to obligate the Corporation upon such contract or transaction; provided, that the fact of such interest shall have been disclosed to the other directors or the stockholders of the Corporation, as the case may be, acting upon or with reference to such contract or transaction.
- (I) The Corporation reserves the right to amend, alter, change, add to or repeal any provision contained in this Certificate of Incorporation in the manner now or hereafter prescribed by statute; and all rights herein conferred are granted subject to this reservation.

I, THE UNDERSIGNED, the incorporator herein before named, for the purpose of forming a corporation pursuant to the General Corporation Law of the State of Florida, do make this Certificate, hereby declaring and certifying that this is my act and deed and the facts herein stated are true, and accordingly have hereunto set my hand this 5th day of March, 2002. I hereby accept the duties and responsibilities as registered agent.
