

**ARTICLES OF INCORPORATION  
OF

The undersigned person, acting as the incorporator of **RUBY'S CUTTIN' UP, INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

**ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS**




Pursuant to Sections 48.091 and 607.0501, Florida Statutes, the following is submitted:
