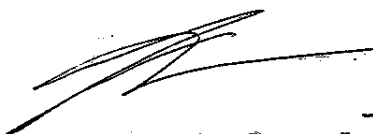

I, the undersigned, hereby associate myself for the purpose of forming a corporation under the laws of the State of Florida under the corporate name of J & J EXCAVATING, INC., and hereby set forth and declare:

**ARTICLE I  
NAME OF CORPORATION**

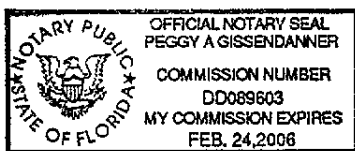

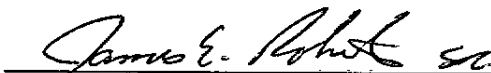
